MAP Welcomes Assistant Professor Elizabeth De Santo

Elizabeth De Santo, PhD (University College London) joined the MAP family in August. Elizabeth will be teaching and conducting research in the Marine Affairs Program, specifically teaching MARA 5013 Marine Protected Areas in the winter term. Her research areas include political ecology, environmental security, institutional effectiveness, marine governance and improving the science/policy interface in environmental decision-making. She is currently examining marine spatial planning initiatives in Europe and North America, and environmental geopolitics in the Arctic.

Elizabeth has been busy since her arrival, working on the preparation of 3 SSHRC grant proposals, 2 of which are with other faculty members, presenting a seminar at MAP titled "Governing Marine Protected Areas", guest lecturing in an Environmental Sciences course and a College of Sustainability course and attending 2 conferences.

In mid-October, Elizabeth co-convened a UNEPsponsored workshop on "Governing Marine Protected Areas: Getting the Balance Right" held in Mali-Lošinj, Croatia. The workshop involved twenty-five leading experts from five continents and seventeen countries around the world who are engaged in Marine Protected Area (MPA) governance at a practitioner and/or research level. The project is being coordinated by Dr. Peter Jones (UCL), Dr. Elizabeth De Santo (Marine Affairs Programme, Dalhousie University), Wanfei Qiu (UCL) and Ole Vestergaard (UNEP Division for Environmental Policy Implementation, Marine and Coastal Ecosystems Branch). Co-hosted by Blue World Institute, University College London and the United Nations Environment Programme, the workshop systematically compared and analyzed a representative range of MPA case studies from around the world as part of a project to develop a good practice guide. For further this project, information on http://www.homepages.ucl.ac.uk/~ucfwpei/pdf/IUC NBalance.pdf. She also traveled to London for a follow-up to the workshop in November. The UNEP report, which Elizabeth is co-authoring, is forthcoming in early 2010.

At the Ocean Management Research Network (OMRN) National Conference in Ottawa in late October, Elizabeth gave a presentation on "Reflections on 20 years of the Precautionary Principle in Marine Environmental Management".

Originally from New York, Elizabeth studied her BA at Connecticut College. Master Environmental Management at Duke University, and Master of Science in the History of International Relations at the London School of Economics. Her PhD was completed in 2007 at University



College London and the title of her thesis was "Offshore marine conservation in the North East Atlantic: Opportunities and challenges for the developing regime".

MAP Projects

Coastal Research Network Secretariat

The Government of Nova Scotia's Coastal Management Framework called for the creation of a coastal research network among public, private and academic research institutions to help advance, promote, conduct and disseminate quality research on coastal issues in Nova Scotia and Atlantic Canada in support of coastal management and the provincial Sustainable Coastal Development Strategy. The Government of Nova Scotia established the Coastal Research Network Secretariat (CRNS) within the Marine Affairs Program earlier this year to facilitate the creation of the network and eventually coordinate its activities. One of the key activities of the CRNS has been the creation of a database of information related to coastal management in Nova Scotia and Canada, including specialists Atlantic organizations related to the six priority coastal issues. In the New Year, the CRNS will be organizing a kick-off workshop to formally establish the network which will provide a means for research and academic institutions to directly influence coastal and ocean management in Nova Scotia. Chris Burbidge, MMM 2008, is the coordinator of the CRNS.



Marine Spatial Planning

Marine spatial planning (MSP) is widely seen as an ideal mechanism for managing marine and coastal areas. MSP involves using comprehensive knowledge of natural and human activities in the marine and coastal area, their interactions and a singular long-term vision for the management to determine the ideal allocation of marine space and time for any given marine activity. There is particular interest in implementing MSP in Atlantic Canada and this research focuses on some of the legal elements surrounding such an implementation.

Three specific elements relating to **MSP** implementation have been reviewed by this research: (1) a review of the existing Canadian legislation which could be used to implement MSP; (2) the legal and legislative designs of existing MSP regimes in Europe; and (3) the mechanisms for facilitating federal-provincial cooperation for MSP projects in Canada. Three papers on the aforementioned topics have been produced for the Canadian Department of Fisheries and Oceans and they are currently being edited for potential publication.



Don McCrimmon is the Research Assistant working on this project with Lucia Fanning. Don completed his Masters in Law at Dalhousie University in the spring of 2009 and has been working with the Marine Affairs Department since then. He is an avid cyclist and traveler, recently combining both passions bicycling around Cuba. Currently, Don is working on new research on how MSP can be applied in the Canadian context before he returns to the Dalhousie Law School next fall to pursue his PhD in Law.

The symposium was hosted by the Marine Law Institute at the University of Maine and the Marine Environmental Law Institute at Dalhousie University. Lucia Fanning, MAP Director, gave a presentation titled "Ocean Jurisdiction and Energy: Exploring Bi-National Policy Options for Georges Bank".

MAP Class Field trips Joggins Fossil Cliffs



On October 16, the MMM students in the Management Without Borders class travelled to Joggins Nova Scotia to visit the Joggins Fossil Cliffs UNESCO World Heritage site (http://jogginsfossilcliffs.net/), Jenna Boon,

Director of the Joggins Fossil Institute and MMM student, was the host for the visit. Jenna and her staff gave presentations on the process of how the Joggins Fossil Cliffs became a World Heritage site. They also described the key and unique green building technology that was used for the building and surrounding landscape. The visit concluded with a guided tour of the fossil cliffs. From all accounts, Joggins is highly recommended as a place to spend a day.

Bear River First Nation



John Kearney took the students of MARA 5012 Community Based Co-Management class to visit the Bear River First Nation reserve in Bear River, Nova Scotia in late November. During the drive to Bear River, major land marks and historical facts were pointed out as many of the students had not yet traveled to the Annapolis Valley. Upon arrival at the Bear River First Nation band office, the group headed out to the site of one of the stream restoration projects. Robert McKwan, the band's resource manager, explained the principles of stream restorations, the techniques they used, and the improvements they have seen in stream quality and the return of traditional fish species. Sherry Pictou, a former chief and the co-coordinator of the World Forum of Fisher People talked about the struggles of the Bear River First Nation in defending their fishing and traditional use rights. She also talked about many dimensions of community-based co-management that are part of the subject matter of MARA 5012. Sherry had just returned from Rome where she had participated in civil society activities associated with the FAO meetings on food security. After Sherry's talk, the regularly scheduled class of MARA 5012 took place with student presentations. The field trip

concluded with delicious fish chowder prepared by Robert McKwan.

Clark's Harbour and Woods Harbour

The students of MARA 5021. Fisheries Management, toured the coastal fishina communities, Clarks Harbour ad Woods Harbour on Sunday November 29th, prior to the opening of the 2009 lobster season in South Western Nova Scotia. A tour of Xsealent Seafoods by the owner, Terry Zinck provided an opportunity to learn, first hand, some of the issues facing fish packers and buyers involved in the groundfish and lobster fisheries.

Lunch with the Nova Scotia Minister of Fisheries and Aquaculture, Hon. Sterling Belliveau, was followed by an impromptu guided tour by the minister of the Woods Harbour, where preparations were well underway for the lobster fishery. Student also had an opportunity to learn more about the emerging hagfish fishery from Kevin Amirault, a lobster fisher from Lower West Pubnico.

The day long tour was a fitting way for students to experience the efforts made by fishers and buyers to prepare for the lobster fishery, to understand the scope of investment made by individual fishers to participate in the fishery, and to appreciate the importance of this industry to the coastal communities of South Western Nova Scotia.
