Accomplishments: Usability Studies

- Usability study # 1
- Carousel not used as navigation tool
- Subject guides recognition of subject organization, scrolling was not an issue
- Databases most used dropdown, Research Tools pages could be improved
- Catalogue preference for WCL over Novanet
- Interface preferred Switch to Novanet
 - Usability study # 2
 - Current navigation
- Using the Library → Research Tools → Writing & Style Guides → Subject Guides → Collections → Locations & Services
 - Proposed

Challenges

- Hours automation (#headmeetsdesk)
 - eg. <u>UNB</u>
- Communication
 - Priority list, authorship, adding new pages
- Limitations of CQ5
- Limitations of Campus Web guidelines
- Digital Collections ~1500 pages to move from Joomla... requires development work (objects, assets 7000 objects/photographs)
