Vice-President and Professor of Philosophy, Mount Allison University; author of articles, reviews, and addresses on philosophy, education, and the history of Newfoundland.

E. H. KING

Associate Professor of English and Assistant Dean of Junior Studies, Memorial University of Newfoundland; author of articles on eighteenth-century history, education, and literature; a book on James Beattie, to be published in Twayne's English Literature series, is almost complete.

ALICE HAMILTON

Associate Professor of English, University of Winnipeg; co-author, with her husband, Kenneth Hamilton, of *John Updike: A Critical Essay* and *The Elements of John Updike*; author of monographs, articles and reviews, published in England and Canada, on medieval and modern subjects; a book, *Stained Glass in Manitoba*, is to be published in September, 1970, by the University of Winnipeg Press; a review of poems and stories by John Updike will appear in the Autumn issue of *The Dalhousie Review*.
