Introduction

This Library Council Annual Report summarizes activities from September 2019 through June 2020. Donna Bourne-Tyson served as Chair, Linda Clark as Secretary and Carol Richardson as Recording Secretary. From March – June of 2020 All Library Council business was conducted remotely and special thanks go to Carol Richardson for her file management skills and steady support, especially during this transition.

Overview

Council continued to function as a planning and information sharing venue for all libraries and library-related matters. Its membership fluctuated during the term as special leaves, retirements and new hiring created a fairly fluid list of voting and non-voting members. In mid-March of 2020 the norms surrounding the way Library Council conducted business and held meetings were disrupted by the closure of Dalhousie University campuses. This unprecedented action came in response to public health advice as the COVID-19 pandemic spread throughout the province. Library staff at all locations were asked to begin working from home and this pivot to remote working created many challenges for managers and the staff they supervise. Beginning with the March 26 Library Council meeting, attendance moved to Microsoft Teams. It became apparent at that meeting that many of our staff were dealing successfully with new work-from-home regimes. Attendance at this and subsequent Library Council meetings was very good, prompting discussion of possibly maintaining the Teams meeting format even when staff return to some on-site activities.

From that point onward, the monthly meetings provided an excellent opportunity for the Dean of Libraries to update Council on various COVID-related decisions and for our members to clarify information coming from several different sources. More than ever, Library Council became an important point of contact for colleagues who would not otherwise have an opportunity to see or hear from each other during the last four months of Council's term.
