LIFE INSURANCE EXAMINATIONS.

Dear Doctor:-

The question of Examination Fee for
Life Insurance was dealt with at the Annual Meeting of the Nova Scotia Medical Society. The Valley
Medical Society presented through Dr. J.A.Sponagle
of Middleton, a Resolution. This Resolution had
the following Recommendation:-

"No examination for Life Insurance

less than \$5.00 and that the N.S.Society take

action along this line and Practitioners throughout the Provine be notified by Circular or
otherwise."

The Committee on Insurance who had this Resolution under consideration made the following Recommendation:-

"That this Society approve and support the Resolution of the Valley Medical Society in conformity with report from Special Committee of Medical Society of Nova Scotia, dealing with this matter."

The adoption of this recommendation was moved by Dr. Johnstone, Sydney, and seconded by Dr. M.E.Armstrong.

It was moved as an amendment by Dr. Egan, Sydney, seconded by Dr. A.E.G.Forbes, that examination for Insurance im for the Old Line Companies by \$5.00 after January 1st, 1922, and that the Profession be circularized to this effect.

Carried.

It was moved by Dr. Egan, seconded by Dr. Sullivan, that the Committee of this Society on Insurance be retained, that they communicate with the Insurance Companies and report at the next Annual Meeting. Carried.
