Board of Governors Meeting Dalhousie University Motions to be Proposed April 20, 1999

Be It Resolved:

- 9 (i) THAT, based on the recommendation of the Student Relations and Residence Committee, the Board of Governors approve Dalhousie Student Union fees of \$56 per term for full-time students, \$28 per term for part-time students, and \$5 per term for off-campus students, for the fall and winter terms, effective September 1999. The Committee also recommends the approval of the fees for student societies effective September 1999 as presented.
- 9 (ii) THAT, based on the recommendation of the Student Relations and Residence Committee, the Board of Governors approve mandatory athletic fees for full-time students effective September 1999 of \$43 per term for the fall and winter terms, and \$22 for the spring/summer term.
- 9 (iii) THAT, based on the recommendation of the Operations Committee and the Student Relations and Residence Committee, the Board of Governors approve the 1999 2000 tuition fee schedule as presented.
- 9 (iv) THAT, based on the recommendation of the Student Relations and Residence Committee, the Board of Governors approve the establishment of a mandatory fee for Health Services of \$8 per student per term effective September 1999.
- 10. THAT, based on the recommendation of the Student Relations and Residence Committee, the Board of Governors approve the 1999 2000 schedule of Residence and Board rates as presented.
- 11. THAT, based on the recommendation of the Student Relations and Residence Committee, the Board of Governors approve the Student Assistance Program allocations as presented.
- 12. THAT, based on the recommendation of the Nominating Committee, the Board of Governors approve the appointment of the following individuals to represent the students of Dalhousie University on the Board of Governors effective May 1, 1999 for one year: Ms. Kelly MacKenzie, Mr. David Lovas, and Mr. Shawn Tracey.
- 13. THAT, based on the recommendation of the Operations Committee, the Board of Governors approve the proposed allocation of funds for 1999 -2000 alterations and renovations, subject to the receipt of the expected amount of restricted operating funds.

- 14. THAT, based on the recommendation of the Operations Committee, and in order to allow the continued operation of the University until such time as the 1999 2000 operating budget is given final approval, the Board of Governors authorize expenditures of up to 25% of the 1998 1999 approved budget for Dalhousie University. The President or his designate is authorized to approve expenditures in excess of 25% in special cases to permit the orderly management of the University.
- 15 (i) THAT, based on the recommendation of the Senate, the Board of Governors approve the proposal for a Diploma in Nurse Practitioner Studies for Remote and Under-Serviced Communities.
- 15 (ii) THAT, based on the recommendation of the Senate, the Board of Governors approve the proposed program, B.Sc. (Minor in Environmental Studies).
- 15 (iii) THAT, based on the recommendation of the Senate, the Board of Governors approve the proposed Master of Applied Science in Biomedical Engineering with the following conditions:
 - ① ERBA for the M.A.Sc. Students only be credited to the School of Biomedical Engineering
 - ② the Faculties of Medicine and Engineering transfer funds to the University Library for the identified library requirements:
 - for the retrospective upgrade, one-time payments of \$3,265 from Engineering and \$6,530 from Medicine, and
 - 2 for ongoing requirements, a permanent base budget transfer of \$5,625 from Engineering and \$11,250 from Medicine
 - ③ the source of scholarship funding to be provided from University funds for the M.A.Sc. students be identified and agreed upon by the President's Office and the Faculty of Graduate Students.
- 16. THAT, based on the recommendation of the Senate, the Board of Governors approve the proposal to create the School of Biomedical Engineering.
- 17. THAT, based on the recommendation of the Senate, the Board of Governors approve the name of the program in Agricultural Engineering be changed to Biological Engineering.
- 18. THAT, based on the recommendation of the Senate, the Board of Governors approve the name of the Department of Biochemistry be changed to the Department of Biochemistry and Molecular Biology.
- 19. THAT, based on the recommendation of the Operations Committee, the Board of Governors approve the sale of a property on Porters Lake.

Each year up to three awards are given to students for exceptional contributions or leadership in the extracurricular life of the university or in the area of community service, combined with very good academic records. This year's winners include Derek Chaudhary, Sasho MacKenzie, and Douglas Gordon (who is unavailable this afternoon).

Derek completed a Bachelor of Science degree in 1996 and will graduate in May from the Master of Health Services Administration program. He was honoured for many years' participation in the Indian Students' Association, Treasurer of the Dalhousie Association of Graduate Students, extensive community involvement with the Metro & District Ambulance Service, the Youth Alternative Society, Grace Wesleyan Church, Halifax G-7 Summit, IWK Grace Hospital and IWK Children's Wish Foundation, the Abbie Lane Hospital; involvement in numerous intermural sports; and as a disc jockey at the Grawood Lounge.

Sasho is a third year student in Kinesiology and was honoured for his participation in two AUAA/CIAU sports - Assistant Captain of the Men's Volleyball Team, and as a member of the Track & Field Team; for his accomplishments as an athlete, in particular his selection as a Royal Bank CIAU All-Canadian for the past two years; but also for the example he shows for other athletes in terms of commitment and work ethics; for his service as a member of Student Athletics Council; as a volunteer tutor in Physics, Exercise Physiology and Biomechanics; and as a coach of the track & Field team at his former high school.

Douglas is a second year student in the Bachelor of Nursing program and was honoured for service as Nursing Society representative to the DSU, a role in which he has been effective at fostering communication and a sense of partnership with "upper campus"; for promoting Nursing and Health on campus as C0-Chair and Treasurer, Halifax Students for International Health; an organizer of the International Health Conference with related displays in the Tupper Link and the SUB; a booth organizer for the 1998 Health and Wellness Fair; and for community service - Co-Chair of the Dalhousie Chapter of Habitat for Humanity, involvement in the Children's Wish Foundation Bowlarama, the Alzheimer's Society Campaign and Shinerama.
